

Sleep Health Data Privacy Policy

SleepIQ Technology and Sleep Number App

We collect Sleep Health Data when you:

- Use a Sleep Number mattress with SleepIQ technology enabled
- Create a Sleep Number sleeper profile in the Sleep Number app
- Use the Sleep Number app
- Enter information into the Sleep Number app
- Choose to connect the Sleep Number app with a Third-Party Service

Your use of SleepIQ technology enables us to provide you with SleepIQ services. SleepIQ services include data collection, data analysis, and inferences we may draw from your Sleep Health Data, aggregated data from SleepIQ technology, or sleep science insights to provide you with personalized content (“SleepIQ Services”).

When using a Sleep Number mattress with SleepIQ technology, you can choose to disable the transmission of Sleep Health Data to us by turning on “Privacy Mode” in the Sleep Number app. This will stop the transmission of new Sleep Health Data while Privacy Mode is on. We will continue to maintain the Sleep Health Data that we have already collected from you, but in Privacy Mode the only information transmitted to us is your app and remote interactions, and that your pump is online and generally operational. With Privacy Mode on, the Sleep Number app can still be used to control the Sleep Number setting, the bed base, and other bed features; data needed to enable these features will be processed locally on your device and will not be transmitted to us. Some features, such as obtaining your SleepIQ score, will not be available with Privacy Mode on. If you later turn off Privacy Mode, this will resume the transmission of Sleep Health Data.

The Sleep Health Data that we collect from you through your use of SleepIQ technology may be considered “sensitive data” or “consumer health data” under the privacy laws of some states. We only process this information after we have received your consent. We obtain your consent through the Sleep Number app. You have the right to withdraw this consent at any time. You may withdraw your consent by contacting customer service at 1-800-554-0184, or through Account Settings in the Sleep Number app, to delete your Sleep Number sleeper profile. If you withdraw your consent, we may not be able to provide certain services to you. We will advise you if this is the case at the time you withdraw your consent. So that we can provide you the SleepIQ Services you have requested, we maintain your Sleep Health Data until you withdraw your consent or otherwise notify us that you are no longer using the services and submit a verified request to delete this information. The Sleep Health Data we collect from you varies depending on which Sleep Number mattress you use and how you choose to use the Sleep Number app, including your use of Privacy Mode. The BreathelQ app was discontinued on January 30th, 2026.

Following the discontinuation of the BreathelQ app, we have not retained your snore recordings, measurements, or any other data associated with your use of BreathelQ. We will continue to retain your transactional information, including your purchase information, name, email address, and phone number, consistent with the Transaction & Engagement Data section of our Privacy Policy.

Sharing Sleep Health Data

We do not sell any of your Sleep Health Data or use it for targeted advertising as defined by applicable law. We may share your Sleep Health Data with the following categories of third parties:

Trusted Vendors and Partners

So that we can provide our products and services to you we share Sleep Health Data with select vendors and business partners for the purposes identified in the table above. We limit the information we share with these vendors to what is necessary to achieve these purposes.

Parties to Business Transfers

We may disclose each of the categories of Sleep Health Data as part of a corporate transaction or proceeding such as a merger, financing, acquisition, bankruptcy, dissolution, or a transfer, divestiture, or sale of all or a portion of our business or assets.

Government Entities, Law Enforcement, or other Third Parties

We may share each of the categories of Sleep Health Data with government entities, law enforcement, insurers, courts, or other third parties where we believe it is necessary comply with applicable law or court order.

Your Choice to Share Information

You may choose to disclose your Sleep Health Data through our ratings and reviews pages, social media pages, and other similar services to which you are able to post information and materials. Depending on the third-party page's or service's guidelines and policies, your posts may become public. We urge you to be mindful when deciding to disclose any information.

We may also share and use for any purpose information that does not identify you individually and is not linkable to you, including: (1) information that is collected in a manner that does not identify you individually and (2) information that was collected as Personal Information but later de-identified to remove the information that could be used to identify you or link you to the information ("De-Identified Information"). We will not attempt to re-identify De-Identified Information.

Privacy Rights

You have the following privacy rights related to your Sleep Health Data:

- **Right to Know:** You can request to access the Sleep Health Data we have collected from you along with a list of the third parties with whom we have shared your Sleep Health Data.
- **Right to Delete:** You can request we delete the Sleep Health Data that we have collected about you.
- **Right to Correct:** You can request that we correct any inaccurate Sleep Health Data that we maintain about you.
- **Right to Appeal:** If your request is denied, you may also appeal that decision. If you live in the state of Washington and your appeal with us is unsuccessful you can submit a complaint with the Washington State Attorney General at <https://www.atg.wa.gov/file-complaint>.
